B. Bolte asked S. Sefcik to read the Hearing Notice for the record.

B. Bolte requested public speakers to identify themselves and their residence

1. Washington Montessori School Association, Inc., Couch Rd (Map 5 lots 5&6)
Engineer, CiTao, presented details of the plans to put in new soccer field and tennis courts and to relocate some of the parking area. Washington permits are currently with their Wetlands Commission. Residents were very concerned with the lighting that may or may not be seen from their properties. There will not be any lighting on the tennis courts or at the soccer field. One driveway/parking light (lamp) will be relocated and one additional lamp will be added on the Warren property. All other lighting is located on Washington property. Some questions concerning the grading of the fields and slopes were answered by Mr. Tao. There were some questions concerning landscaping and how much of the current tree line would be affective: what materials would be used for the parking lot and tennis courts. Mr. Tao answered the questions of how the landscaping would be; would keep at least 100 feet tree line from property line: asphalt for driveway/parkinglot and concrete for tennis courts. Questions concerning the possibility of tennis summer camp and what that would entail. Since Mr. Tao is the engineer and not a school representative, he was unable to answer some of the questions.

The Commission felt there were multiple questions unanswered and felt a school representative should attend to answer these questions. Motion (Brodhead/Miller) to continue the hearing until October 14, 2014 at 7:30pm at the Warren Town Hall and a representative from the Montessori School would need to be present to answer the public's questions All in Favor
