Meeting called to order at 5:00 pm by First Selectman LaCava

1) Minutes of December 5, 2023, Meeting: Motion (Baker/LaCava) All in Favor Motion passes 2-0-0 Schneiderbeck wasn't in attendance at the 12/5/23 meeting to vote.

4) First Selectman's Report:

- RSD20 A vote on the school's name was held on 12/14/23. The name Lakeview High School
 was voted on 157-132. RSD6 is winding down and most of the meetings now are about
 transferring assets to the new R20.
- Social Services -read report.
- DPW -read report.
- Park and Recreation read report.

It is with a heartfelt thank you and appreciation to all our volunteers who serve on our committees, commissions, and boards along with all those who volunteer in the community on different organizational boards and commissions. From the entire Town Hall Staff and the DPW Crew, we wish you a very Merry Christmas, Happy Holiday, and a Happy New Year.

- We finished replacing the dishwasher at the Wasley property this past week along with repairing some electrical work.
- Mailing being stolen from mailboxes and the blue PO Box in the center of Town has been happening over the past month. LaCava is working with CSP and the Postal Investigated Services on the matter. A new secure PO Box has been ordered by the Postal Service but is backordered. We suggest mailing your payments directly at the post office or if you are dropping them off at the PO Box in town, do so before the daily pickup. Don't leave mail in boxes overnight. Report any stolen mail to CSP and the Post Office Master.
- Attended the first COG meeting with 7-8 newly elected CEO's. A Covanta representative
 attended to give an update on the garbage situation. Thankfully we don't have this problem
 with BRRFOC. Our only complaint is the long wait time for dumping since it's a smaller plant we
 use.
- Our new maintenance person has been helping DPW catch up and is now in the process of transitioning over to the maintenance side of the budget. He is working under the supervision of J. Tanner and LaCava depending on the work.

- Been meeting with my assistants on budget items we proposed last year and where we stand to complete these items. We will be starting work on the new budget right after the new year.
- Attended a Litchfield County Fire Chiefs meeting. Some items discussed included mutual aid, declining volunteers, and radio/communication problems. The lack of radio signals in areas is a safety concern – there are spots where even police are in a dead zone. Health screening for volunteers and paid fire fighters was also on the table.
- Been working with Homeland Towers and J. Favreau on possible funding to help with attracting a carrier.
- Continue to work with Warren Affordable Housing on grants. We have the documents to sign for CDBG waiting on assistance from the State.
- Signed the contract with East River Energy for next year on diesel and gas prices happy to say we are \$.30 per gallon lower than this year.
- Completed the grant paperwork for the Early Voting Grant for towns. Early Voting will start with the primary in April, which was not included in the budget State didn't have any definite information on how this new voting would be implemented. The grant is for \$10,500 to each town based on needs ours is for staffing.
- Gave the BOS a draft of possible new rental fees for facilities will discuss in January.
- Wrote a letter to the Agricultural Commission on RSD6's benefit for a grant.
- Gave\ the BOS a review of the training the staff did over the past year.
- Shared with BOS a Town Score Reporting will email the report to BOS tomorrow. This is a report based on different aspects of our Town. Usually used as a marketing tool. Looking into the "free" components of the program.
- Working with Social Services on a new prescription program because the Foundation of Community Health will be dissolving at the end of the year.
- D. Schneiderbeck gave an update on Land Trust new trails on Cunningham Rd.
- LaCava discussing possible new communication avenue with doing a video of the Town where
 we possibly highlight different areas of the Town on a quarterly basis. Would be on our website
 but will continue to research the idea.
