Bd of Finance/Selectmen Minutes Special Meeting June 4, 2020 via Zoom

Board of Finance members present: Susan Haxo, James Richardson, Eric Schoenfeld, Robyn Kasler, David Robinson (in meeting as of item 3), Luke Tanner

The meeting was opened at 7:00 pm by chair Susan Haxo. She took a roll call attendance and noted that the meeting was being recorded and that since it is a special meeting there will be no public comment.

- 1. Minutes of May 20, 2020 special meeting: *J.Richardson moved to accept the minutes of the May 20, 2020 special meeting*. Second by L. Tanner. A roll call vote was taken. All in favor, the motion carried 5-0-0.
- 2. E. Schoenfeld moved to authorize the Selectmen to apply for and accept State and Federal Grants for the FY 2020-2021 budget Per Executive Order 7JJ #4 Allowance of Suspension of In-Person Voting Requirements by Members of the Public for Critical and Time-Sensitive Municipal Decisions. Second by R. Kasler. A roll call vote was taken. All in favor, the motion carried 5-0-0.
- 3. Discussion and action on FY 2020-2021 Town Budget: S. Haxo read a statement explaining how the comments on the budget were received and reviewed with a synopsis of the comments. Statement is attached. *D. Robinson moved to adopt the proposed 2020-2021 Town Budget.* Second by J. Richardson. Discussion followed. E. Schoenfeld also read a statement (attached). D. Robinson and J. Richardson both expressed their views in favor of the salary increases. A roll call vote was taken. All in favor, the motion carried 6-0-0.
- 4. *R. Kasler moved to set the mill rate for fiscal year 2020-2021 at 14.25 mills.* Second by D. Robinson. A roll call vote was taken. All in favor, the motion carried 6-0-0.

J. Richardson moved to adjourn at 7:16 pm. Second by E. Schoenfeld. A roll call vote was taken. All in favor, the motion carried 6-0-0.

As we begin, I would first like to sincerely thank each and every town resident who weighed in on the proposed budget by offering their comments, both pro and con. This is Warren at its best, with a healthy and passionate debate.

The members of this Board were more concerned with the content of the comments than with specific numbers. The opinions were split very evenly but purely from a number's standpoint, we received more comments in support of the budget than opposing it. <u>All</u> the comments become part of the public record, and will be included with the minutes of this meeting.

Most of the positive comments mentioned our holding the line on taxes as part of their decision. There were some comments about fairness toward town employees, and some compliments about the smooth running of town government. Those comments were very gratifying.

There were a small number of comments that <u>this</u> employee should get a bigger raise than <u>that</u> employee. We tried to get all the town hall workers to the median of their counterparts in similarly situated towns. A case can be made that some employees – who may have more experience or more advanced degrees – deserve more. That's why we built in a "compensation adjustment" line in the budget, which would give the Selectmen a chance to make things equitable.

The comments opposing the budget seemed to fall into one of three categories: The first was an objection that town residents were being denied their right to vote in a Town Meeting. Believe me, a Town Meeting would have been our choice, too...but that choice was taken out of our hands by the Governor's Executive Order. That order has the force of law, and each member of this Board took an oath to uphold the law. Because of the lack of a Town Meeting, I would say the Board spent more time and effort debating and weighing the merits of this budget than we have in any recent year in memory.

The second category of objection was that many people are being laid off during the COVID-19 epidemic, so we shouldn't be giving town workers who are still employed any significant raises. Like you, we feel terrible about people losing their jobs or having a rough go of things during the epidemic. But to adopt a stance that some are being hurt therefore everyone should not do well just doesn't seem fair. It's <u>not</u> cause-and-effect. Raises for town employees will not mean anyone else who lives in town will get laid off. There is no increase in the mill rate, so no taxpayer will be hurt...No one should end up any worse off.

The third major objection is that the school budget, which is <u>down</u> this year, will go up <u>next</u> year. If there had been <u>no</u> decrease in the school budget this year, we were still well-positioned to adopt this budget without any tax increase. Not only is our general fund balance very healthy – you can see that in the annual audit – but we received a \$180-thousand dollar Town Aid Road grant from the state that we frankly never expected to get, and didn't budget for. That goes right to the bottom line.

If the school budget goes up next year – let's say back to the level it was at this year – we should have no major issue weathering that storm. And by the way, the school budget represents about 60 percent of Warren's total budget. The school budget doesn't have to go up. You as a town can vote against it in 2021. This Board has no control over the school budget...but YOU do.

The proposed budget was originally sent to us by the Board of Selectmen, with all three of them approving it. The Board of Finance made some changes that reduced the amount of raises by about 40 percent. That revised budget...the one before us today...was also unanimously approved by the three Selectmen. It has their support.

With that, I will entertain a motion to adopt the proposed budget as the Fiscal 2020-21 budget for the Town of Warren, and we can open it up to further discussion by the Board.

I'd like to sincerely thank everyone who took the time to write us with their comments. I hope you will take the same level of interest in town government the rest of the year, and not just for the two weeks of budget time.

How do you determine if a town government, or a town budget, is any good? I believe there are four major questions you have to ask:

Number One: Am I <u>safe?</u> Am I safe...is my family safe...is my neighborhood safe? In a budget, that translates to, "is there enough money allocated to police, fire and ambulance services?"

The second question: Are my children and grandchildren getting a good education? Is there enough money in the school budget?

Number three: Are my roads plowed and sanded in the winter and repaired and maintained during the rest of the year?

And four: Are the most vulnerable in our community being taken care of? Is there adequate funding for social services?

After those four, there's a whole second tier of questions. Is my trash and recycling picked up without incident? My brother lives in Massachusetts and used to have to take his trash to the dump. I only have to take mine to the top of my driveway. Does the town provide programs and recreational activities for all ages? Is there a place to swim? Is there a place to borrow the latest books and movies? Can I get a permit when I need one? Can a get a copy of my deed or other important records?

The final question, and it's a biggie, is "How much do I have to pay for all that – the safety, the schools, the roads, everything?" We in Warren are fortunate to have one of the lowest tax rates in the state...so we pay less than almost all the other towns in Connecticut.

If you can check all those boxes, that's a town government that works. And "town government" is not some amorphous "thing"...It's not a concept. It's a group of dedicated, hard-working, competent people who keep the town running smoothly for us. For us.

The proposed budget may not be perfect, but I believe it checks all the boxes. I support the town government, and I support this budget.

I am writing this letter on behalf of myself and my husband, in hopes that it can be submitted or read at the next Board of Finance Meeting on May 7th. I have a few questions and points of concern that I hope can be addressed as you all decide on the final town budget.

I would like to preface my questions with a thought. This is an unprecedented year. This is a time where many people in our town are out of work or have had their pay cut dramatically. It is a time where the fiscal state of the country and state are VERY uncertain. This is the first time that I can remember where the approval of the budget rests on your shoulders alone and we as town voters will not have the opportunity to vote on a town budget. With all that in mind I feel strongly as a voter that we should maintain the status quo and keep the budget as close to what it was last year when the voters did have a say.

With that being said, I hope that as you decide on a final budget that you will consider these questions and thoughts.

- 1) Lots has been said about making salaries comparable to other nearby towns. Have you considered that although the proposed salaries would be comparable to say a Kent or Goshen, the town composition and the workload of the town hall staff may not be comparable? For example, Kent has 2x as many people as Warren, many more businesses and their town hall is a full time town hall. If this hasn't been considered, I encourage it to be discussed.
- 2) Have you explored the idea of spreading out the raises over the course of the next 3 years just to be sure they are sustainable?
- 3) Can some of the raises be approved (for example the tax collector earned her certification per an agreement) while others are put on hold or spaced out?
- 4) Once a budget is approved by the BOF, how will the board decide what changes to make based on town feedback? In other words, what is the measurable amount needed to "over ride" the BOF decision? For example, if over 50% of the letters come in asking for it to be changed will it? Or do you need to get letters from 50% of the town's people. I saw that Kent has sent out a survey monkey survey to get a feel for voters opinions. Could we send a similar survey. It seems to me a decision needs to be made on how you will measure the town voters "approval" versus "disapproval" in order to respect the democratic process.

Those are the questions that I have. I plan to listen in to the BOF meeting next week and I appreciate all of the hard work and deliberation that all of you have put into this. It is not easy volunteering on town boards during such an unprecedented time.

Yes, this is and will be a year of trying times. In your letter to us, the neighbors, you seem to say that you are concerned with your towns use of your tax dollars.

In light of these very difficult financial times for many of the non government employees in the country, we would like to express our thoughts.

Your letter to the people states that there would be no tax increase with the purposed budget. You neglected to tell the people that within the total budget that after many, many years of school budgets with excessive spending the school budget for 2021 was reduced my \$157,000 (-4.8%) thru no effort from the board.

Putting education behind, we see that your proposal for the administration spending of the proposed budget will increase \$160,000 (6.8%). We already spend close to 2.5 million dollars to administrate government in this small town of roughly 1,400people. You are spending \$1,800 for each man, woman, and child in town. Thinking we have roughly 400 residential homes in town that is over \$6,000 per household.

There comes a time when spending should be really looked at to determine what is really needed and the efficiency of each department. Within the budget there must be many areas that can be cut and not always increased, burdening the tax payer.

As soon as we have a clearer view of how 2021 and 2022 are shaping up, this topic can be revisited and the salaries can be reviewed based on the independent report, which was just concluded.

With 20% unemployment and a possible 50%+ GDP contraction, the revenue outlook for the State of Connecticut is negative and Warren's revenue stream through real-estate tax income is not quaranteed.

GENERAL GOVERNMENT - SALARIES

A large expense position in the budget is Town Hall personnel cost.

According to the 2020/21 budget proposal, this item will increase by a staggering 32% compared to the 2018/19 budget numbers due to large pay increases and additional hours.

Based on the proposed budget Town Hall would cost the taxpayers of Warren \$796,074 (incl. employee benefits), an increase of 27% vs \$627,478 in 2018/19. That comes to \$1,303 for every family in Warren. I do not believe now is the right time for these large increases.

The most glaring change is for the position of the TAX COLLECTOR – a salary increase of 90%. It was explained that it is due to higher qualifications, but his/her hours will also increase by 25% - no reason given.

Other positions within the Town Hall would receive increases between 21% to 50%.

COMPENSATION REVIEW ADJUSTMENT

I am against the creation of the expense position "Compensation Review Adjustment" into which \$15,000 would be placed. As was discussed in a previous BOF meeting, this position was created as a fund out of which salary increases would be paid to some. I do not support salary increases by more than 2 %. Furthermore, I believe all salaries should be transparent and listed in the line for the respective positions in the budget proposal.

PARK AND REC

I suggest to review the paid hours for the position of the Park and Recreation Director for whom currently 25 paid hours per week are allocated. That's 5 hours per day, 5 days a week. I propose that the hours are reduced in view of the current situation, with social distancing and no or diminished travels, bus rides, events, etc.

PARK AND RECREATION FUND

\$34,000 are supposed to go into the Park and Rec fund. According to the auditor's report dd. June 30, 2019 (page 12) Park and Rec carries a fund balance of \$80,958. I learned at the recent BOS meeting that these funds are in a separate checking account outside the control and view of the BOS. I wonder whether this is proper and what these funds are for. I suggest to strongly reduce the budget allocation.

EDUCATION EXPENDITURES

The largest annual expense is for education. The town's share depends on the number of Warren students attending RSD #6.

Warren is in a lucky situation this year. For 2020/21 its cost contribution will decline by \$156,925 or 4.8%.

The numbers for the following years are beyond our control - they could easily go up by several \$100's K.

Currently, RDS #6 has earmarked \$2,580,000 in financial support from the State of CT (ASTE Tuitions and Grants). A loss of that funding, which is possible given the tight financial situation of the State of CT, would hit Warren with its current share of 18% = \$464,400. In addition, there have been on and off talks about passing on the teacher's pension payments to the local towns.

Talking about pensions - Warren has its own pension plan problem. The pension plan fund is heavily underfunded and does not fulfill its purpose.

In reviewing the proposed budget, I was surprised to see the huge increase in salaries proposed for several positions. While I understand that the study you conducted showed that these salaries were below those generally found in other towns, there are two factors that I think you should consider. First off, our Country and State are going through an unprecedented economic recession that will take a lot of effort to get out of; now is not the time to increase town expenditures unless absolutely necessary. Secondly, my belief is that Warren is a generally well-off, pleasant place to live and work; jobs such as collecting taxes and running the town hall are likely easier to do here than in towns and cities with fewer means. Maybe that is why the market for certain positions at the Town Hall commands lower salaries than elsewhere in the State.

As a taxpayer I understand some of the concerns some residents have regarding the budget for 2020/2021. But as an employee and elected official of the Town I see the other side of the situation. In keeping with Tim's idea of transparency, You, the Selectmen, and employees know that this salary issue started with the First Selectman hiring a new Land Use officer for \$10 more an hour than the last certified officer which (a) is \$3.00 per hour higher than the average salary per the COG survey, and (b) is an increase of 49.9% for the proposed budget. Yes, this person is qualified for this position, but discrimination against current employees who are just as qualified and certified in their positions, not to mention the number of years employed, is unacceptable in the workplace. Yes we are a part time office, but we are a one person office and still need to provide services to our residents no matter the number of hours worked. Larger towns have multiple employees in each department to share the responsibilities and duties in order to provide services to their residents. This is not a political ploy against Tim and we are not trying to push this through in a hurry, we are just asking to be treated fairly. Even though I am not in agreement with the \$15,000 Compensation Review line and feel those employees should have their wages corrected, I do understand your reasoning behind this. I know when trying to compare the social services director and the park and recreation director in this area was difficult because you need to compare our town against other towns with employees with the same degrees, licenses and services. I am confident you will continue to monitor this line item and make sure it will be used as you intended and to make sure this issue is properly researched and resolved by the Selectmen quickly. As for the constant attack on the Tax Collector, residents should be aware that this person took classes and passed all the exams to be a certified tax collector in the State of CT over the past 3 years. The average salary is \$36+ per hour and her salary was only increased to \$30 and that is based on the hiring agreement. As for hours calculated for employees, this is based on the number of hours for that position each week with a few extra hours added to the year to take in account the extra hours they may have for meetings, training sessions and conferences. Residents should also know that the Town of Warren is an EMPLOYER and like any other employer, personnel are the responsibility of the employer. Town employees have rights like any other employee in the State of CT.

Having said all this, I appreciate the efforts from each Board Member. Thank you for all your research and time taken to make a sustainable budget, trying to correct a bad situation and taking the extra steps to make sure residents were able to comment during these extraordinary times.
