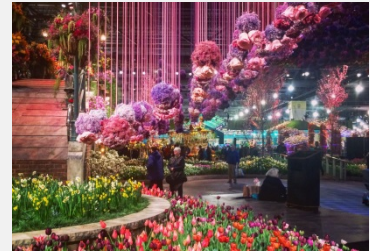


BOSTON FLOWER SHOW
