- 4) Additions to Agenda: AED Question T Angevine to Board: Who maintains the AED's for the Town? Nelson usually the Selectmen's office and we use the medical outfit in New Milford for supplies for the AED
- 5) Public Works New 6-wheel dump truck per truck replacement plan: Angevine sat down with Tanner (Road Foreman) to review the replacement plan that has been in place for a few years now. This truck is part of the 15 year rotation, which is now 17 years old *Motion* (Angevine/Papp) to approve the request and send to the BOF for approval to purchase a new 6 wheel dump truck as part of the replacement plan not to exceed \$200,00 All Approved
