Session I: Boys and girls, ages 6 and up; meets Saturdays, November 18, Dec. 2, 9, 16, 2017, 7-8 a.m., Kent School Ice Rink with instructor Joanna Dumitrascu; cost is \$44. Lessons for beginning students, 7-7:30 a.m.; intermediate level and above meet 7:30-8 a.m. Students registered for classes (only) also may skate during the 30 minutes opposite their lesson time. Pre-register by Nov. 12.

Session II: Meets Saturdays, January 6, 13, 20, 27, 2018; same schedule as above with instructor Marika Coolbeth. Cost is \$44. Pre-register by December 22.

Session III: February 3, 10, 17, 24, 2018; same schedule as above with instructor Marika Coolbeth. Cost is \$44. Pre-register by January 26. **There are no make-up dates for cancellations; students may skate at the P&R open skate at Kent and South Kent Schools during holiday/winter skating without charge.**
